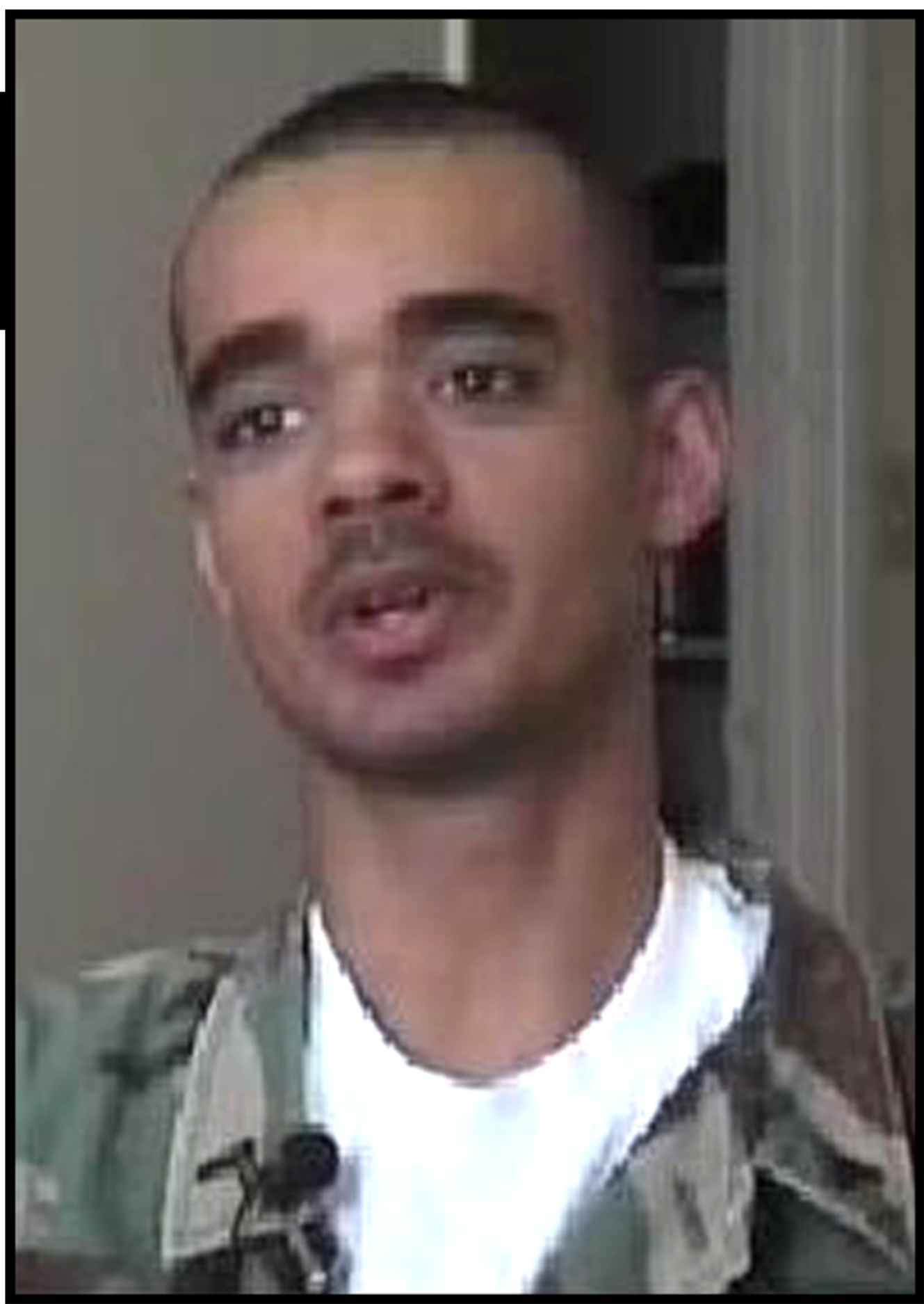


JESSE ADAM MACBETH
